






Figure 1. Static Characterstic




Figure 3. DC Current Gain




Figure 5. Base-Emitter Saturation Voltage




Figure 2. DC Current Gain




Figure 4. Collector-Emitter Saturation Voltage





Figure 6. Output Capacitance




Figure 7. Reverse Biased Safe Operating Area

Figure 8. Forward Biased Safe Operating Area




Figure 9. Power Derating Curve
