




Figure 1. Static Characteristics




Figure 3. Saturation Voltage




Figure 5. Resistive Load Switching




Figure 2. DC Current Gain




Figure 4. Saturation Voltage




Figure 6. Resistive Load Switching




Figure 7. Reverse Biased Safe Operating Area




Figure 9. Forward Biased Safe Operating Area


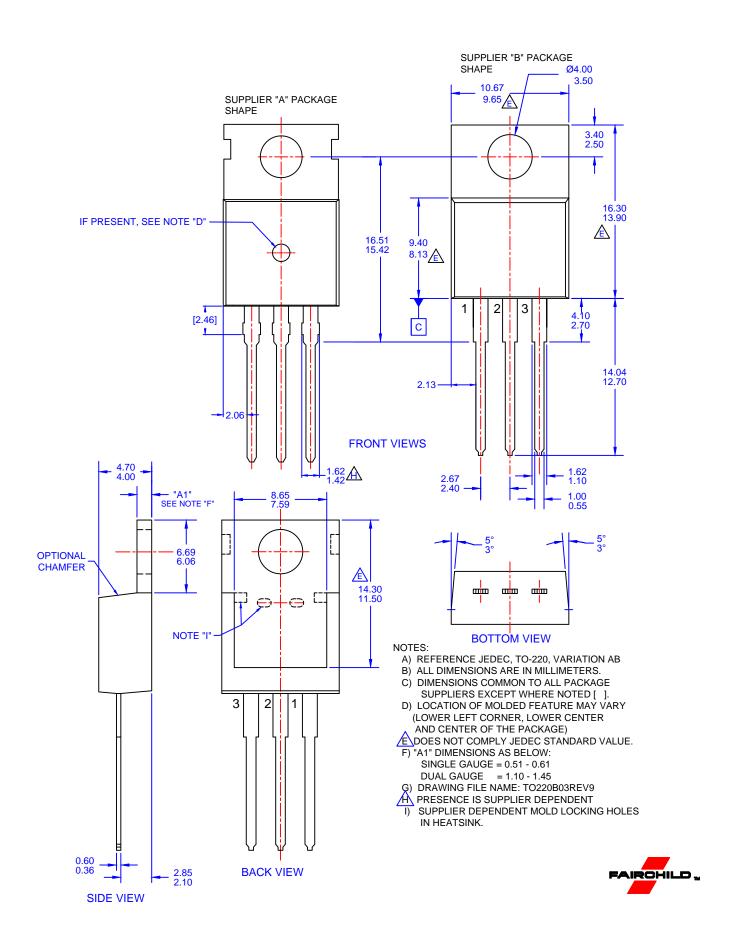


Figure 8. Power Derating
