


Figure 1. DC Current Gain




Figure 2. Base-Emitter Saturation Voltage Collector-Emitter Saturation Voltage




Figure 3. Output Capacitance




Figure 4. Current Gain Bandwidth Product




Figure 5. 3 LEAD, SC90, EIAJ SC-70, 1.25 MM WIDE (ACTIVE)
