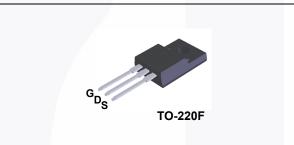

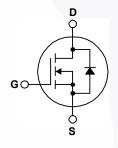
Description
