




Figure 1. Base-Emitter Saturation Voltage vs.
Collector Current




Figure 3. Collector-Emitter Saturation Voltage vs.
Collector Current




Figure 5. Current Gain vs. Collector Current




Figure 2. Base-Emitter On Voltage vs.
Collector Current




Figure 4. Input/Output Capacitance vs. Reverse Bias Voltage




Figure 6. MOLDED PACKAGE, SUPERSOT, 3-LEAD (ACTIVE)
