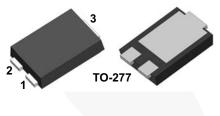


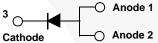

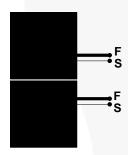


Figure 1. Minimum Land Pattern of 2 oz Copper

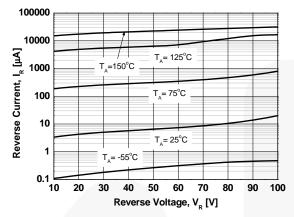
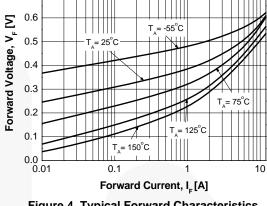


Figure 3. Typical Reverse Characteristics

Figure 4. Typical Forward Characteristics

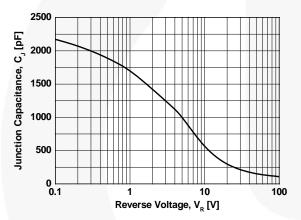


Figure 5. Typical Junction Capacitance

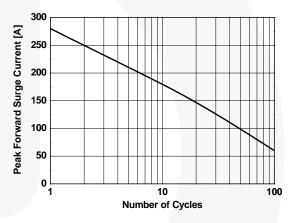


Figure 6. Maximum Non-repetitive Peak Forward **Surge Current**

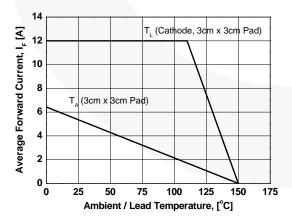
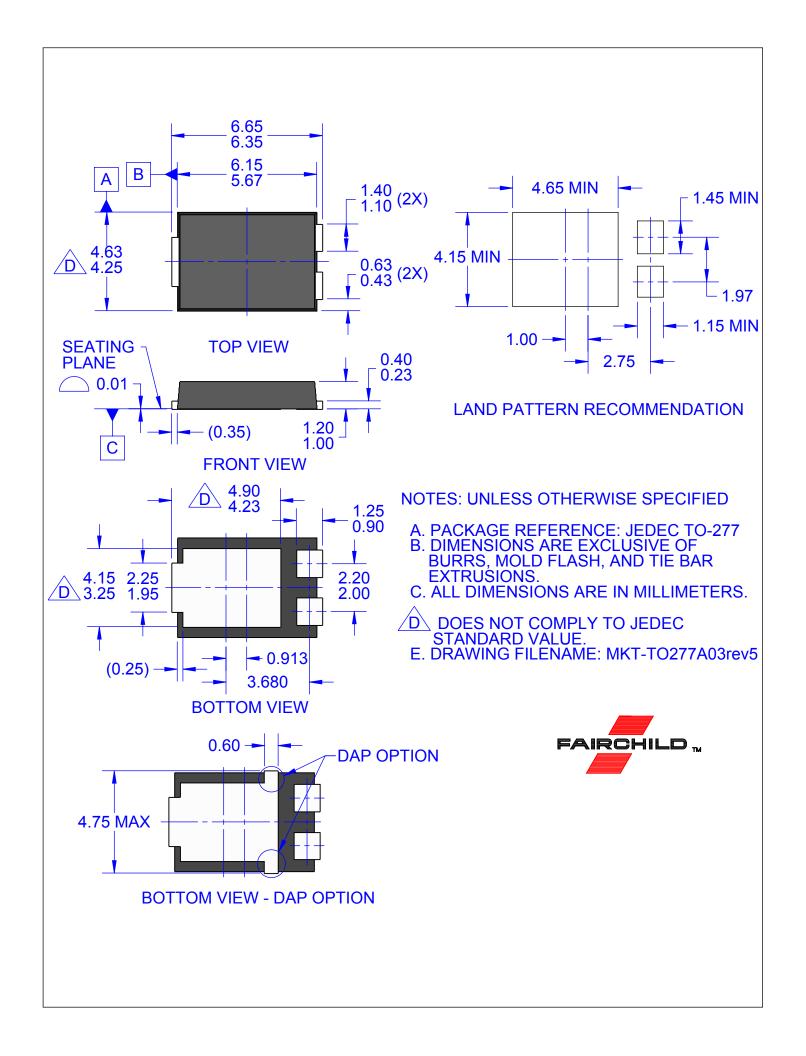


Figure 7. Forward Current Derating Curve
