

Figure 1. Minimum Land Pattern of 2 oz Copper





Figure 2. Maximum Land Pattern of 2 oz Copper

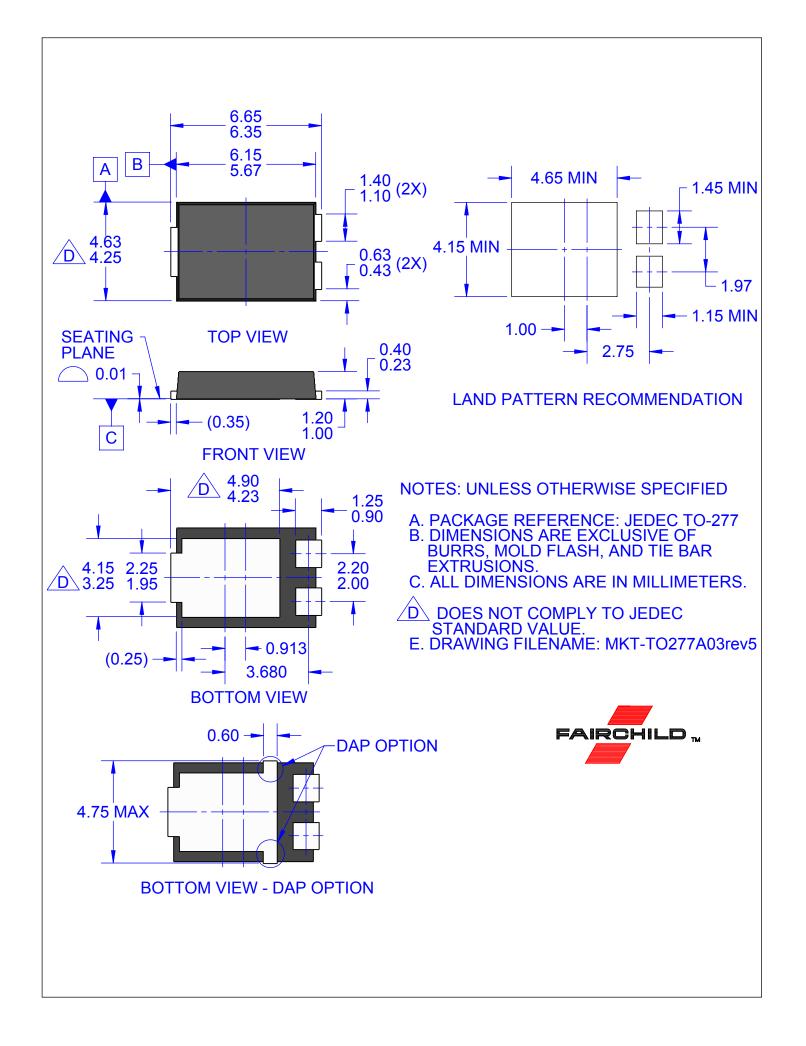
