


Figure 1. DC Current Gain




Figure 2. Collector-Emitter Saturation Voltage and Base-Emitter Saturation Voltage




Figure 3. Base-Emitter On Voltage




Figure 4. Current Gain Bandwidth Product






Figure 5. 3-Lead, TO-92, JEDEC TO-92 Compliant Straight Lead Configuration, Bulk Type
