

Description

The KA337 / LM337 are 3-terminal negative adjustable regulators. They supply in excess of 1.5 A over an output voltage range of -1.25 V to -37 V. These regulators require only two external resistors to set the output voltage and employ current limiting, thermal overload protection, and safe area compensation.

Block Diagram




Figure 1. Block Diagram




Figure 2. Line Regulation vs. Temperature




Figure 3. Load Regulations vs. Temperature




Figure 4. Adjustable Pin Current vs. Temperature




Figure 5. Adjustable Pin Current Change vs. Temperature




Figure 6. Reference Voltage vs. Temperature




Figure 7. Minimum Load Current vs. Temperature




Figure 8. Noise Voltage vs. Temperature




Figure 9. Ripple Rejection vs. Temperature




Figure 10. Short-Circuit Currents vs. Temperature




Figure 11. Peak Current vs. Temperature





Figure 12. Typical Application
