


Fig. 1. 8/20 μs pulse waveform according to IEC 61000-4-5 and IEC 61643-321




Fig. 2. ESD pulse waveform according to IEC 61000-4-2




Fig. 3. Diode capacitance as a function of reverse voltage; typical values




Fig. 4. V-I characteristics for a bidirectional ESD protection diode




Fig. 5. Dynamic resistance






Fig. 6. Dynamic resistance

10. Application information

The device is designed for the protection of up to two bidirectional data lines from surge pulses and ESD damage.



Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

- 1. Place the device as close to the input terminal or connector as possible.
- 2. Minimize the path length between the device and the protected line.
- 3. Keep parallel signal paths to a minimum.
- 4. Avoid running protected conductors in parallel with unprotected conductors.
- 5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
- Minimize the length of the transient return path to ground.
- 7. Avoid using shared transient return paths to a common ground point.
- 8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.





Fig. 11. Package outline DFN1006-3 (SOT883)
