

Current vs. Time (8/20µs, I/O to V_{SS})




Figure 2 Breakdown Voltage, Trigger Voltage, Holding Voltage vs. Ambient Temperature







Figure 4 Forward Voltage Characteristics



Current vs. Time (8/20µs, V_{CC} to V_{SS})




