






Top View

Top View Pin-Out





Safe Operating Area




Transient Thermal Impedance




Pulse Width (s)






VCE(sat) v IC


VCE(sat) v IC

VBE(sat) v IC




Ic - Collector Current (Amps) **VBE(on) v IC**


