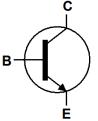



Top View Pin Configuration









Fig. 8 Typical Gain-Bandwidth Product vs. Collector Current


