Fig. 6 On-Resistance Variation with Temperature




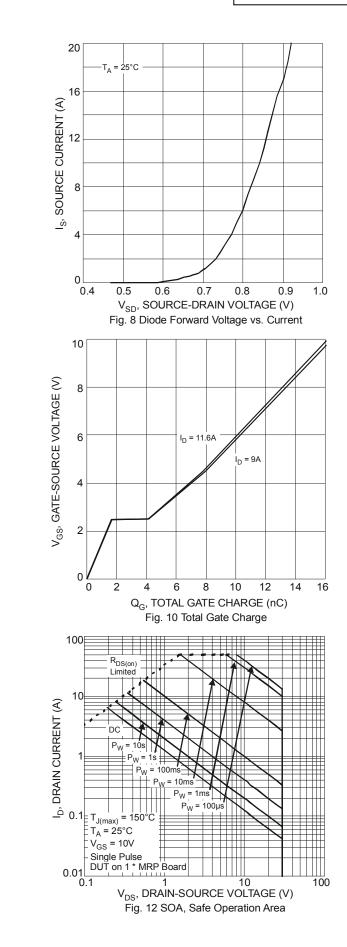
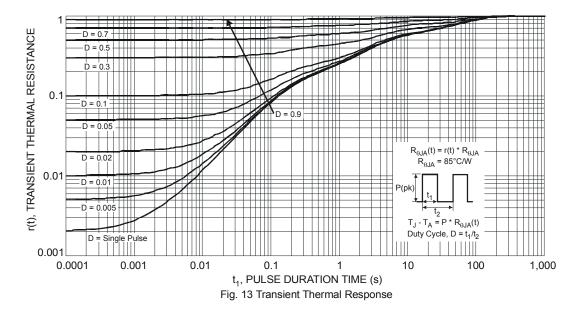


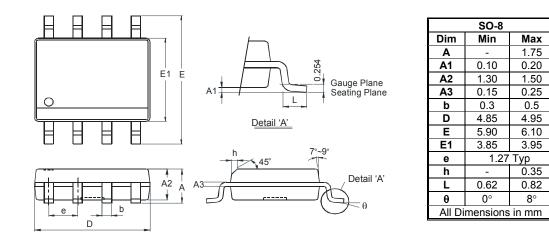
Fig. 11 Typical Leakage Current vs. Drain-Source Voltage








Package Outline Dimensions
