




Figure 1. Typical Pulsed Current Gain vs. Collector Current




Figure 2. Collector-Emitter Saturation Voltage vs. Collector Current




Figure 3. Base-Emitter Saturation Voltage vs. Collector Current




Figure 4. Base-Emitter On Voltage vs. Collector Current




Figure 5. Collector Cut-Off Current vs.
Ambient Temperature




Figure 6. Input and Output Capacitance vs. Reverse Bias Voltage




Figure 7. Switching Times vs. Collector Current




Figure 8. Turn-On and Turn-Off Times vs. Collector Current




Figure 9. Rise Time vs. Turn-On Base Current




Figure 10. Power Dissipation vs. Ambient Temperature




Figure 11. Common Emitter Characteristics




Figure 12. Common Emitter Characteristics




Figure 13. Common Emitter Characteristics
