FAN431A Programmable Shunt Regulator

Description

The FAN431A is a three-terminal output adjustable regulator with thermal stability over the full operating temperature range. The output voltage can be set to any value between V_{REF} (approximately 2.5 V) and 36 V with two external resistors. This device has a typical dynamic output impedance of 0.2 Ω . Active output circuit provides a sharp turn-on characteristic, making this device excellent replacements for zener diodes in many applications.

Block Diagram




Figure 1. Block Diagram




Figure 2. Test Circuit for V_{KA}= V_{REF}




Figure 3. Test Circuit for $V_{KA} \ge V_{REF}$




Figure 4. Test Circuit for I_{KA(OFF)}




Figure 5. Shunt Regulator




Figure 6. Output Control for Three-Terminal Fixed Regulator




Figure 7. High-Current Shunt Regulator




Figure 8. Current Limit or Current Source




Figure 9. Constant-Current Sink




Figure 10. Cathode Current vs. Cathode Voltage




Figure 11. Cathode Current vs. Cathode Voltage




Figure 12. OFF-State Cathode Current vs.
Ambient Temperature




Figure 13. Reference Input Current vs.
Ambient Temperature




Figure 14. Frequency vs. Small Signal Voltage Amplification




Figure 15. Pulse Response




Figure 16. Stability Boundary Conditions




Figure 17. Anode-Reference Diode Curve




Figure 18. Reference-Cathode Diode Curve






Figure 19. Reference Input Voltage vs. Ambient Temperature
