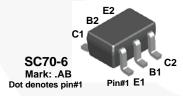

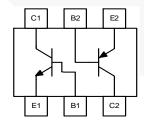

Block Diagram

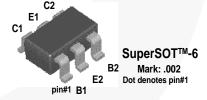


FFB3946 Device Package

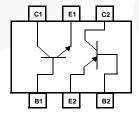


FFB3946 Internal Connection

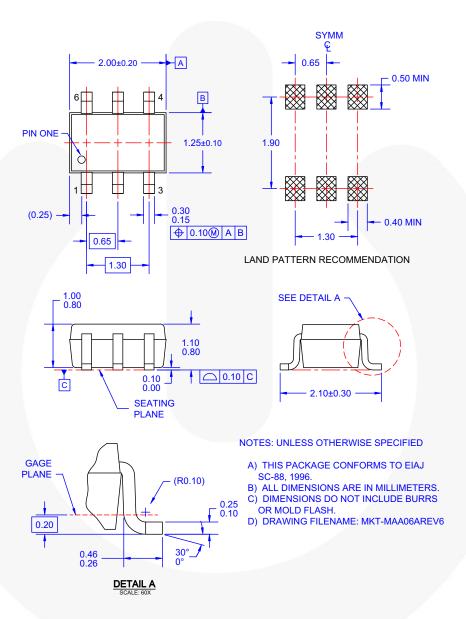


Figure 2. 6-LEAD, SC70, EIAJ SC-88, 1.25 MM WIDE (ACTIVE)

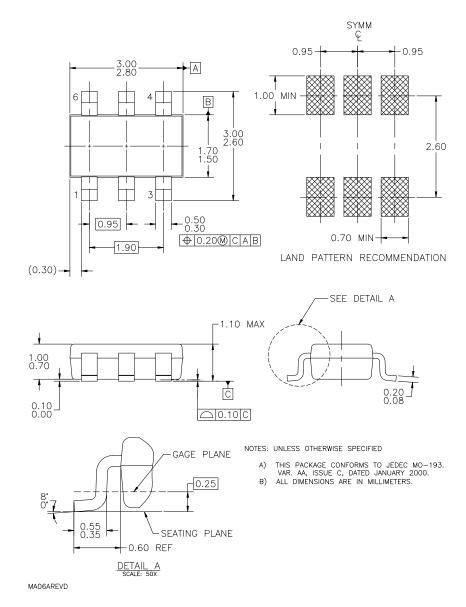


Figure 3. 6-LEAD, SUPERSOT6, JDEC MO-193, 1.6 MM WIDE (ACTIVE)
