


Fig. 1. RMS on-state current as a function of surge duration; maximum values





Fig. 2. RMS on-state current as a function of solder point temperature; maximum values





Fig. 4. Non-repetitive peak on-state current as a function of the number of sinusoidal current cycles; maximum values





Fig. 6. Minimum footprint SOT223







Fig. 9. Normalized gate trigger current as a function of junction temperature




Fig. 10. Normalized latching current as a function of junction temperature





Fig. 11. Normalized holding current as a function of junction temperature






Fig. 13. Normalized gate trigger voltage as a function of Fig. 14. Normalized critical rate of rise of off-state voltage as a function of junction temperature; typical values





Fig. 15. Package outline SC-73 (SOT223)
