

# Description

The SC4212 is a high performance positive voltage regulator designed for applications requiring very low input voltage and very low dropout voltage at up to 1 Ampere. It operates with a VIN as low as 1.5V, with output voltage programmable as low as 0.5V. The SC4212 features ultra low dropout, ideal for applications where VOUT is very close to VIN. Additionally, the SC4212 has an enable pin to further reduce power dissipation while shutdown. The SC4212 provides excellent regulation over variations in line, load and temperature.


The SC4212 is available in a 3 x 3 MLPD-8 package. The output voltage can be set via external divider or to a fixed setting of 0.5V depending upon how the FB pin is configured.

# **Pin Configuration**












# **Pin Descriptions**

Pin #	Pin Name	Pin Function	
1,4,5	NC	No connect.	
2	EN	Enable Input. Pulling this pin below 0.5V turns the regulator off, reducing the quiescent current to a frac- tion of its operating value. The device will be enabled if this pin is left open. Connect to VIN if the enable feature is not being used.	
3	VIN	Input voltage pin. For regulation at full load, the input to this pin must between (VOUT + 0.5V) and 6V. Minimum VIN = 1.5V. A large bulk capacitance should be placed close to this pin to ensure that the input supply does not sag below 1.5V. Also a minimum of 4.7 $\mu$ F ceramic capacitor should be placed directly at this pin.	
6	VOUT	This pin is the power output of this device. A minimum $10\mu F$ capacitor should be placed directly at this pin.	
7	FB	When this pin is connected to the VOUT pin , the output voltage will be set to 0.5V . If external feedback resistors are used , the output voltage will be determined by the resistor ratio (See Application Circuits on page 1): $V_{OUT} = \frac{0.5 \cdot (R_1 + R_2)}{R_2} \cdot \text{Volts}$ $R_1: \text{ The resistor connected from VOUT to FB.}$ $R_2: \text{ The resistor connected from FB to GND.}$	
8	GND	Reference ground. The GND pin and the thermal pad must be connected together at the IC.

### **Applications Information**

#### Introduction

The SC4212 is intended for applications where high current capability and very low dropout voltage are required. It provides a very simple, low cost solution that uses very little PCB real estate. Additional features include an enable pin to allow for a very low power consumption standby mode, and a fully adjustable output.

#### **Component Selection**

**Input capacitor**: A large bulk capacitance of  $\ge 10\mu$ F should be placed close to the input supply pin of the SC4212 to ensure that VIN does not sag below 1.5V. Also a minimum 4.7 $\mu$ F ceramic capacitor is recommended to be placed directly next to the VIN pin. This allows for the device being some distance fromany bulk capacitance on the rail. Additionally, input droop due to load transients is reduced, improving load transient response. Additional capacitance may be added if required by the application.

**Output capacitor:** A minimum bulk capacitance of  $\geq$  10µF, along with a 0.1µF ceramic decoupling capacitor is recommended. Increasing the bulk capacitance will improve the overall transient response. The use of multiple lower value ceramic capacitors in parallel to achieve the desired bulk capacitance will not cause stability issues. Although designed for use with ceramic output capacitor ESR values and thus will also work comfortably with tantalum output capacitors.

**Noise immunity:** In very electrically noisy environments, it is recommended that 0.1  $\mu$ F ceramic capacitors be placed from VIN to GND and VOUT to GND as close to the device pins as possible.

**External voltage selection resistors:** The use of 1% resistors is recommended.

**Enable:** Pulling the EN pin below 0.5V turns the regulator off, reducing the quiescent current to a fraction of its operating value. A pull up resistor up to  $400k\Omega$  should be connected from the EN pin to the VIN pin in application

where an input voltage of < 1.9V is required. For applications with input voltages higher than 1.9V, the EN pin could be left open or connected to VIN.

#### **Thermal Considerations**

The power dissipation in the SC4212 is approximately equal to the product of the output current and the input to output voltage differential:

$$\mathsf{P}_{\mathsf{O}} = (\mathsf{V}_{\mathsf{IN}} - \mathsf{V}_{\mathsf{OUT}}) \times \mathsf{I}_{\mathsf{OUT}}$$

The absolute worst-case dissipation is given by:  $P_{O(MAX)} = V_{IN(MAX)} - V_{OUT(MIN)} X I_{OUT(MAX)} + V_{IN(MAX)} X I_{Qt(MAX)}$ For a typical scenario, VIN = 3.3V ± 5%, VOUT = 2.8V and  $I_{OUT} = 1A$ , therefore:

 $\begin{array}{l} \text{VIN}_{\text{(MAX)}} = 3.465\text{V},\\ \text{VOUT}_{\text{(MIN)}} = 2.744\text{V} \text{ and}\\ \text{I}_{\text{O(MAX)}} = 3\text{mA} \end{array}$ 

Thus 
$$P_{D(MAX)} = 0.731W.$$


Using this figure, and assuming  $T_{A(MAX)} = 70^{\circ}$ C, we can calculate the maximum thermal impedance allowable to maintain T<sub>1</sub> ≤ 125°C:

$$R_{TH(J-A)(MAX)} = \left(\frac{T_{J(MAX)} - T_{A(MAX)}}{P_{O(MAX)}}\right) = \left(\frac{125^{\circ}C - 85^{\circ}C}{0.722W}\right) = 76^{\circ}C_{W}$$

This should be achievable with the 3mm x 3mm MLPD-8 package using PCB copper area to aid in conducting the heat away, such as one square inch of copper connected to the ground pins of the device. Internal ground/power planes and air flow will also assist in removing heat. For higher ambient tempertures it may be necessary to use additional copper area.



### Outline Drawing — 3mm x 3mm MLPD-8


