



Fig. 6 - Typical Recovery Current vs. dl_F/dt (Per Leg)






Fig. 9 - Reverse Recovery Parameter Test Circuit




Fig. 10 - Reverse Recovery Waveform and Definitions

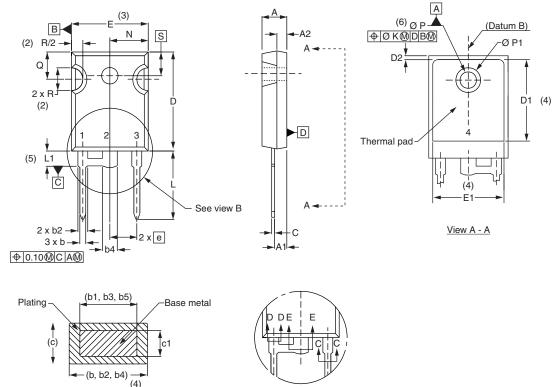
